From North, Take route 287 to exit 35, Madison Ave. in Morristown NJ. Turn right off the exit ramp onto Madison Ave. it will merge with South St. at the first traffic light. Continue to The Vail Mansion on your right just before Miller Rd. on your left

From the south take route 287 north to exit 35 and turn left at the top of the ramp onto South street. Continue to the merge with Madison Ave. and follow directions above. (See map on other side)

- **This is a fine arts and fine crafts** show with about 80 spaces available. We will create separate Fine Art, Jewelry and craft courts.
- **Ribbons** from other shows may not be displayed.
- **We** do not charge a commission on sales.
- **All spaces** are pre-assigned. Volunteers will be available to assist you in locating your space.
- **Information** about parking will be given during setup. Coffee & muffins provided on Saturday morning.
- **Deadline:** May 15th After that a late fee of \$75.00 will be imposed on all spaces, and payments will be cash or money order. Locations assigned as received. We will take applications until all locations are filled.
- **Jury:** All media will be juried online, or by slides or photos. Exhibitors accepted in one of the last 3 years exempted. Please send photos of your work and one photo of your exhibit from a previous show..
